Applicants should also possess a Ugandan Certificate of Education with at least five passes (or its equivalent) and a Uganda Advanced Certificate of Education with at least two principal passes obtained at the same sitting (or its equivalent).

All Graduate Programmes are **PRIVATELY-SPONSORED**. Therefore applicants seeking sponsorship should have their applications endorsed by their respective sponsors where applicable.
