ANNOUNCEMENT FOR AUGUST INTAKE 2021/2022 ACADEMIC YEAR ADMISSIONS FOR, POSTGRADUATE DIPLOMA, DIPLOMA AND CERTIFICATE PROGRAMMES OFFERED AT MUBS MAIN CAMPUS, REGIONAL CAMPUSES AND PRIVATE AFFILIATED INSTITUTIONS

The School Registrar, Makerere University Business School, invites applications from Ugandan, East African, S. Sudanese and International applicants for Diploma Programmes under private sponsorship Scheme for the 2021/2022 Academic Year.

The details are as follows:

➤ **POSTGRADUATE DIPLOMA PROGRAMMES**

- a) Each applicant should **either** have obtained at least a Bachelors degree or its equivalent from a recognized institution or an appropriate professional qualification like ACCA, CPA, CIM, ICSA. **Certified copies of Academic Transcripts (not photocopies of certified copies) from the awarding Institutions MUST be attached.**

➤ **DIPLOMA PROGRAMMES**

- a) Each applicant should **either** have obtained the Uganda Certificate of Education (UCE) with at least 5 passes and the Uganda Advanced Certificate of Education (UACE) with at least 1 principal pass and two subsidiary passes in principal subjects obtained at the same sitting.
Or
b) Hold the Uganda Certificate of Education (UCE) with at least 3 passes and hold an Academic Certificate qualification from a recognized Institution or a Certificate in Business Studies offered by UNEB with at least 5 passes obtained from different stages. **Certified copies of academic transcripts (not photocopies of certified copies) from the awarding Institutions MUST be attached.**
Or
c) Applicants with Professional Qualifications must have passed at least a half of Stage/Level One of the professional qualifications from a recognized institution and a Uganda Certificate in Education (UCE) with at least three passes.

➤ **HIGHER EDUCATION CERTIFICATE IN BUSINESS STUDIES(OFFERED AT MUBS MAIN CAMPUS AND REGIONAL CAMPUSES ONLY)**

- a) Each applicant should have obtained the Uganda Certificate of Education (UCE) with at least 5 passes and the Uganda Advanced Certificate of Education (UACE) with at least 2 subsidiary passes or 1 principal pass obtained in principal subjects.
Or
b) Vocational Qualifications at level 2 or level 3 of the Uganda Vocational Qualifications Framework or hold an Academic Certificate qualification from a recognized Institution

➤ **CERTIFICATE PROGRAMMES**

Each applicant should have a Uganda Certificate of Education (UCE) with at least 3 passes at the same sitting.

HOW TO APPLY

1. Applicants are required to apply online by filling in an online application form from any location where there is internet connectivity or **MUBS main campus Nakawa**.
2. Other relevant information can be obtained from the **School Registrar's, Office Block 5** or can be downloaded from the website www.mubs.ac.ug.
3. Candidates who hold Grades **X, Y, Z, 7** and 9 of O'level results should **not** apply because they are **not** eligible for admission.

E. MAKERERE UNIVERSITY BUSINESS SCHOOL ON-LINE APPLICATION PORTAL USER GUIDE

Steps to follow

1. To access the system log on <https://apply.mubs.ac.ug> or www.mubs.ac.ug and click on **Apply Now**.
2. Sign up using your full name, e-mail and mobile number. Please note that your name must be similar to the one on your supporting academic documents for your application to be considered.
Note: For you to register you must have a valid email address. If you do not have one sign up for one.
3. A password will be sent to both your e-mail and mobile number.
4. The system will prompt you to change the password to the one you can easily remember
5. **To fill the form, click on one of the displayed running scheme that suits you.**
6. Click on submit to generate a payment reference number of **UGX 30,000/=** application fee (non-refundable) plus a bank charge of **UGX. 3000/=** payable at any bank.
7. After filling in your **Online Application form**, attach the following **scanned** copies.
 - i) Passport Size photo (100KB).
 - ii) Birth Certificate (500KB).
 - iii) 'O' Level Certificate/Pass slip Or Equivalent (500KB).
 - iv) 'A' Level Certificate/Pass slip Or Equivalent (500KB).
 - v) Certified transcript for Degree/Diploma/Certificate holders (If required) (500KB).
 - vi) Previous school/institution Identification card.

Note:

- a. Applicants who completed their studies from outside Uganda, should have their academic documents equated by the Uganda National Examinations Board.
- b. All Diploma and Certificate programmes are offered during the day.
- c. A programme will only run if the break-even number is realized.
- d. Courses will be offered both online and in classroom setting.
- e. Applicants who enroll on the MUBS Diplomas and obtain good grades stand a chance of studying a bachelor's degree programme for only 2 years.
- f. The system is open for application **from October 19, 2021 and will close on Monday November 15, 2021.**

- a) Applicants are strongly warned that cases of impersonation, falsification of information/documents, fraudulent access or giving false/forged/incomplete information whenever discovered, either at registration or afterwards, will lead to automatic cancellation of admission, revocation of award where applicable and prosecution in the Courts of Law.
- b) Do not buy any other documents not originating from the School Registrar's Office. Those who buy them do so at their own risk.
- c) The School Registrar has not appointed any agents to act on her behalf to solicit for additional funds other than the application fee stated above.
