### Prof. Balunywa appeals to Government to fund research in Universities

Makerere University Business School (MUBS) has decried the insufficient funds allocated by the Government for carrying out research in championing economic transformation.

The Principal Prof. Waswa Balunywa noted that Investment in research and development activities is the key to transforming Uganda's economy. He said countries all-over the world that have adopted the initiative are flourishing. He further emphasized that research is not only critical to the economic and social development of society, but it is also critical to the mission of the Institution.

"The major problem we face in carrying out research is the lack of commitment from the Government to support the innovation," said MUBS principal Prof. Waswa Balunywa.

He said the sh230m allocated for research undertakings for the five public universities was insufficient. "If this country is to change economically, it will only achieve that through research. We appeal to the Government to support us in our innovations to make the lives of the people better," he observed.

The bulk of current research is from development partners, MUBS is appealing to government to increase funding to research and development not only in Makerere but to all public universities, because research is a key activity in Universities.

Balunywa made the remarks during the Makerere University Chancellor Prof. Ezra Suruma's Median visit to MUBS on April 28, 2016.

## Invest in Technical and Vocational Institutions: Prof. Balunywa

"One of the biggest problem in Uganda is talent management and matching talents with the required market. The country is not putting emphasis on the required jobs. To be able to get rid of unemployment in the country, government must invest more in technical and vocational training institutions, because these institutions have the skills that are needed in job creation",

The MUBS Principal Prof. Waswa Balunywa called upon Government to invest more in technical and vocational education and training (TVET) since it has a direct impact on economic growth and job creation.

He noted that Technical and vocational education and training (TVET) is critical for initial skills development and for re-skilling. TVET promotes self-reliance, widens opportunities for people to find a job that fits their talents and preferences and helps them get decent work and a fair income. Therefore, Technical skills are of paramount importance if we are to reduce the level of graduate unemployment in this country. There are no jobs in the country because as a nation, we have not put emphasis on technical and vocational institutions.

Prof. Balunywa made the remarks during the 4th MUBS job and career fair Under the theme, "your Talent and your Network is your Net worthy". The one week event which run form April 18-22, 2015 intended to bring together the employers and various stakeholders at MUBS, to understand the various career opportunities and the jobs available on the market and how to strive a code between the two.

"A shortage of skilled, productive workers and a mismatch between the types of skills training offered and the skills needed by industry are commonly identified constraints that limit investment and economic growth in country", he noted. He further noted that, there are almost 300, 000 people in universities and tertiary institutions compared to the only 70,000 in the different

technical and vocational institutions. "This is partly the reason why there is massive graduate unemployment. You need more technicians and technologists than engineers. You need more technical people in medicine than doctors but our system is the other way round. We appear to be producing more engineers than technicians. There is need for a major change in the educational policy", he advised.

He said Government should incorporate vocational and technical training at the different levels in the education system. "If we are talking about unemployment, there is a need to address unemployment through creating more positions in education institutions for technical and vocational training".

He further stressed that "our educational system allows young people to simply go into programmes without knowing what they are and what the student will do when he or she graduates. There are over 100 undergraduate programmes in diverse fields. However this information is not known to the thousands of students in the School system. We therefore get people applying for programmes which they are really not sure about.

When we receive students, we go ahead to orient them about the different careers available in the market which are related to our specific programmes", he noted.

Vocational education programs have made a real difference in



the lives of countless young people nationwide; they build self-confidence and leadership skills by allowing students to utilize their unique gifts and talents.



Our Report Willy Gills Okello took a walk with Ms. Alison Barugahare, the custodian of female students' Hostel, the great Berlin hall at Makerere University Business School on Tuesday April 05, 2016, He explored the mighty Berlin

The Great Berlin Hall of MUBS comprises of 277 students out of which 204 students on government sponsorship, and 73 are private students. The Hall doesn't segregate, although there are few private students therein. It is a hall for girls only, although there is one male disabled student who resides there in the first floor and he was permitted by the administration to do so on special and humanitarian grounds since he crawls and uses a wheel chair

for his mobility around the school. The disability students also have their places of convenience and bath rooms separate.

When asked as per the criteria used for the admission of the students in the hall, Ms. Barugahare said that it is always done on the first come first service basis. Other students that also accommodate themselves there are those that were admitted on quarter systems, some sports students etc. She added that what normally attracts the students to stay in

The Great Berlin Hall is that-they are assured of their security. The students stay near their lecture rooms and there is a possibility of reading up to 10:00 pm at night before the Berlin Hall gate is closed at mid night. Another reason why the students are attracted to stay in the Great Berlin Hall is that the rooms are cheaper compared to the outside hostels with their exorbitant rents.


The students also get their meals and breakfast at affordable prices.

As the custodian of the female students, her roles are to ensure that the place is cleaned from both within and without so that it becomes a conducive environment for people to live in. In the event that any student falls sick, she is in a position to carry the sick person to the nearby clinic that is just a stone throw, since she also resides in the campus.

The activities that are done in this hall are fellowships and Bible Studies. These are done to make them be God fearing in order to have moral values in them.

## THE MUBS MAIN LIBRARY

The magnificent Building spread over five floors with a total area of 7200 square metres and a sitting capacity of 1200 students. Membership to the School Library is open to all staff and students, but registration is needed before you can start to use the library. Book borrowing is done using the KOHA Library Management system, hence a requirement for each person intending to use the library to register in order to have your details captured in the system. The Library has five annexes that is GRC Library in Bugolobi, Jinja, Arua, Mbale and Mbarara Campus Libraries.

All Library users must register to have access to library books. A Fresh student should present a passport size photo, original admission letter and an ID from the former school and proof of tuition payments in order to register. Continuing students should bring a passport size photo and a proof of registration from the previous semester. A staff should present an introductory letter from the Department or MUBS Staff ID. External Users can also register and become members after paying a membership fee corresponding to the membership tenure requested for ranging from 1 month to 1 year.

## BORROWING/CHECKING OUT BOOKS;

Users can borrow all library books except Reference materials, Newspapers, Dissertations and other Special collections. Dissertations and other Special collections must be read from within the library. Post graduates students can borrow library materials from any Library

but undergraduate students can only borrow materials from the Main Library. Students from MUBS Study Campuses have libraries in the different centers. External ticket holders can borrow 1 book at a time. Borrowers should ensure that they do not keep the books beyond the stipulated time as this will attract a penalty. This is a check mechanism used to rationalize and safeguard the use of library materials. Defaulter charges are paid at the Bursar's office ONLY after acquiring a charge sheet from the Deputy Director on the advice of the technical person and a receipt brought back to the Library as proof of payment. SECTIONS IN THE LIBRARY: Administrative Unit; This unit is manned by the Deputy Director and assists the Librarian in the general administration of library. It is open from 8.00 a.m – 5.30 p.m. For any queries on the general issues of the library contact, facelai@mubs.

#### Reserve section:

This section keeps all rare copies of materials, Special reports like Government reports, some dissertations and some reserve copies of most titles. This section operates under two shifts, morning and evening and opens at 8.00 a.m and closes at 8.00 p.m. Only one item can be borrowed from this section and defaulting attracts a fine of 2,000 UGX per day. (contact: tkasirye@mubs.ac.ug).

### Open Section

This section holds the general collections and is open from 8.00 a.m to 10.00 pm on weekdays and from up to 6.00 p.m on weekends and public holidays. Library materials are loaned out for 7 days there after a charge of 1, 000 is levied on extra day. Only 2 item can be lent out at a time (contact: itendo@mubs.ac.ug).



## **Entrepreneurship**; the merit of success

rom the practitioners viewpoint, Entrepreneurship can be looked at individual, business process and business outcomes levels. There are some people who have taken it as a career throughout the educational process, others are in entrepreneurship without any logical academic itinerary while others engage in entrepreneurship as a supplementary economic activity along their other routines.

There used to be a lot of debates at the beginning of the 21st Century about whether entrepreneurship can be taught. Thank God the contextual and general conclusions support the teaching of entrepreneurship. Teaching entrepreneurship mainly aims at improving the quality and sustainability of entrepreneurial engagements such as start-ups, corporate entrepreneurship, optimizing resources productivity, strengthening opportunism instincts of learners and skilling students with competitive and feasible risk taking aptitude. In attempting to meet the entrepreneurship skill needs of Uganda, MUBS came up with educational programmes in entrepreneurship. These programmes run from the certificate level through to PhD. At each level, our students gain relevant entrepreneurial capabilities so as to wake their entrepreneurial proclivity up. This thus is the key qualification required to engage in entrepreneurship.

The key players in entrepreneurship are the government (to provide a conducive enterprise development atmosphere), vocational institutions (to provide the technical workmanship), financial sector (to provide the tools of transaction-finances), media (to change the mindset and provide an inspiration platform), business schools (to provide skills and models of business startup, growth and transformation), clergy and families (to champion social mindset change and instilling the entrepreneurial spirit). These players are mainly for the facilitation of the entrepreneurial value and supply chains.

In every discipline and career, there are key activities. For entrepreneurship, the key activities include searching for opportunities, mobilizing resources, championing idea generation, networking for the venture, irrigating the idea where the vision is not yet clear to every member in the business. Unlike in other academic disciplines, there are no specific rules and standards in entrepreneurship practice. The general commercial, civil and criminal laws if the land uphold. This is different from other disciplines like accounting, procurement, medicine, engineering and others that have regulatory constraints. This of course does not mean that you do what you want even when it is wrong. There are ethical guidelines that must be conformed to. Such include intellectual properties and other sector-specific regulations.

It comes with no argument that MUBS has championed entrepreneurship right from the introduction of the concept to the Ugandan Higher Learning sector to the commercialisation of its details. Since the pioneer

graduates in October 2005 (where I was a beneficiary), MUBS continued to reign for now rounds 11 of graduate cohorts. MUBS has also had entrepreneurship training across all academic levels certificate, at diploma, masters and PhD. The institution is also aware that there those are who are not privileged to study up to university yet wish to practice their entrepreneurial proclivity. Thus, an outreach unit for



the business community; the Entrepreneurship Centre was created to cater for the non-academic parties. In order to foster the entrepreneurship mantel, MUBS is planning to start up a business incubation centre to be able to develop practical entrepreneurs.

I have met a number of people asking about career prospects in studying entrepreneurship.

Well, entrepreneurship is the richest academic discipline in the 21st Century. Because of its integrative nature, there are many career opportunities that it carries. Notable and key ones are; graduate start-up, business development managers, operations managers, business process engineering, business value chain management, innovation management, business development service providers, business consulting, business registration service providers, business strategic management. There are many career options for a graduate of entrepreneurship.

What is important is to accept that without knowledge in entrepreneurship, some aspects of work life become complicated.

#### The future of entrepreneurship

The term and its practice have been seen gaining exponential acceptance by researchers, governments, development partners, communities, educational programmes, business communities, clergy, media and individuals. This implies that indeed entrepreneurship holds the global economy at all value and supply chains. What remains to be done is to strengthen and sustain it. There is also pressing need to improve the quality and quantity of entrepreneurial engagements to make them self contained so that entrepreneurship can become a competitive career.

## Principal's benchmarking visit to South Africa

April 15: The Principal Prof. Waswa Balunywa was in South Africa. The primary purpose of the visit was to bring on board South African technical universities and technical and vocational institutions to the CAPA family. CAPA is the Commonwealth Association for technical universities and polytechnics in Africa. Several universities and vocational institutions were visited and there was a lot to learn. The important lesson is that Uganda has not been serious on the development of the technical institutions. It is only MUBS which is not a technical and vocational institution that participates in CAPA.

South Africa is a friendly country, has numerous challenges, many things to learn and many things to cry about. It is the biggest economy probably the wealthiest country but with some of the poorest people.

The important lesson is that Uganda has not been serious on the development of the technical institutions. It is only MUBS which is not a technical and vocational institution that participates in CAPA. In the process, Uganda's TVETs have not benefitted from the benchmarking that takes place in these universities.

Among the institutions we visited, the University of Mpumulanga, UNISA among other institutions, it is clear South Africa has something to show in terms of their TVETs. This reflects on the type and nature of its economy which is highly industrialized by African standards. However they have a long way to go in terms of creating technologically advanced economy that will suit the needs of the millions of the poor blacks who live in tin houses.

### **Akamwesi hikes hostel fees**



The hostel fees for next semester at Akamwesi Hostel Nakawa have scared many residents. most of whom are contemplating to vacate the hostel after the end of this current

(including the writer). All room charges have been increased by Shs100,000/- with the hostel administration citing the post-election inflation

A small double that is at shs. 900,000 has been increased to shs. 1m, a big double that is currently at shs. 980,000 will go for shs.1.1m. Triples that currently cost shs. 750,000 have also been increased to shs. 850,000 per bed. Singles were also increased whereby big singles and small singles that cost shs1.3m and shs. 1.2 respectively will go for shs1.4m and shs1.3m respectively. Many students have been heard complaining with some threatening to report the matter to the University Guild office and administration to resolve what some called "extortion" from the hostel administration.

## FBI hacks into terrorist's iPhone without Apple

The FBI said on Monday 28th March 2016 that with the help of a third party it has found a way to unlock an iPhone without help from Apple and has successfully accessed data on a phone used by a terrorist in December's attack in San Bernardino-California, allowing the agency to withdraw its legal effort to compel the tech company to assist in a mass-shooting investigation.

It said it no longer needs Apple's assistance in unlocking the iPhone 5C used by Syed Farook, and it has asked Riverside, California-based US Magistrate Judge Sheri Pym to vacate her order compelling Apple to assist in the case.

### The Apple-FBI Battle Is Over, But the New Crypto Wars (security Vs privacy) Have Just Begun

The move by FBI ends the legal battle between Apple and the FBI in this particular case, but it doesn't end the overarching battle about National security and privacy which one should be priority. There are hundreds of other iPhones that law enforcement agencies around the country want unlocked, opening Apple to potential litigation across the world. And the government's success at accessing data on the

iPhone also raises some concerns about the security of Apple's devices and the boundaries of the law enforcement has been questioned.

FBI Director James Comey is fighting claims the government lied about its inability to unlock the work-issued iPhone 5C used by the gunman in the San Bernardino terrorist attack without Apple's help but said that "it remains a priority for the government to ensure that law enforcement can obtain crucial digital information to protect national security and public safety, either with cooperation from relevant parties, or through the court system when cooperation fails. We will continue to pursue all available options for this mission, including seeking the cooperation of manufacturers and relying upon the creativity of both the public and private sectors."

## Apple wants the FBI to reveal how it hacked the San Bernardino killer's iPhone

Apple Inc. refused to give the FBI software the agency desperately wanted. Now Apple is the one that needs the FBI's assistance. Law enforcement's ability to now unlock an iPhone through an alternative method raises new uncertainties, including questions about the strength of security in Apple devices. The development also creates potential for new conflicts between the government and Apple about the method used to open the device and whether that technique will be disclosed.

Lawyers for Apple have previously

said the company would want to know the procedure used to crack open the smartphone, yet the government might classify the method.

The agency has shown no interest in telling Apple how it skirted the phone's security features, leaving the tech giant guessing about a vulnerability that could compromise millions of devices.

"One way or another, Apple needs to figure out the details," said Justin Olsson, product counsel at security software maker AVG Technologies. "The responsible thing for the government to do is privately disclose the vulnerability to Apple so they can continue hardening security on their devices."

But that's not how it's playing out so far. The situation illuminates a process that usually takes place in secret, Governments regularly develop or purchase hacking techniques for law enforcement and counterterrorism efforts and put them to use without telling affected companies.
