Nature of the scholarship: Makerere University Business School (MUBS) promotes learning by encouraging, supporting and granting scholarships to first class students at the undergraduate and postgraduate degree level for further studies. This will enable MUBS tap into its excellent students for academic development. The scholarship will be extended to:

- i) TWO (2) students from each of the non-specialised Master's Degree Programmes.
- ii) THREE (3) students from each of the specialized Master's Degree Programmes in Entrepreneurship, Marketing and Leadership.
- iii) One (1) student on each Bachelors' programme at MUBS Main Campus.
- iv) One (1) student on each Bachelor's and Master's Degree programmes at the MUBS Regional Campuses.

Objectives of the policy

- i) Identify first class students and promote scholarship with a view of identifying individuals who can do research and teach.
- ii) To facilitate academic development not only in the institution but also in the country.
- iii) To offer assistantship to those that complete their degree programmes
- iv) To promote learning.

What does the scholarship cover?

- i) The Scholarship will cover 100% tuition waiver but the beneficiary will be required to pay the requisite functional fees:
- ii) The fellowship is valid for a period of one academic year and is renewable annually (once for graduate programmes and twice for undergraduate programmes) subject to satisfactory performance which includes but not limited to attainment of a minimum CGPA of 4.40
- iii) Termination can be by either party when one party fails to meet the requirements of the fellowship.

Who is eligible to apply?

- ii) One must be a First Class degree holder of a programme jointly offered by Makerere University and MUBS or a First Class Diploma holder of a programme offered and taught at MUBS Main Campus or its Regional Campuses in Mbale, Jinja, Arua and Mbarara.
- iii) One must be a citizen of Uganda, not more than twenty six (26) years of age (applicants for degree and masters applicants) or twenty (20) years of age (applicants for Diploma programmes) at the time of application.

POLICY ON GRANTING SCHOLARSHIPS TO MUBS FIRST CLASS STUDENTS

Policy Statement

Makerere University Business School (MUBS) wishes to promote learning by encouraging, supporting and granting scholarships to first class students at the undergraduate and postgraduate degree level for further studies. This will enable MUBS tap into its excellent students for academic development.

Policy objectives

- Identify first class students and promote scholarship with a view of identifying individuals who can do research and teach.
- ii) To facilitate academic development not only in the institution but also in the country.
- iii) To offer assistantship to those that complete their degree programmes.
- iv) To promote learning.

Operationalization of the policy

The scholarship will be extended to:

- i) Two (2) students from each of the non-specialized Master's Degree Programmes;
- ii) Three (3) students from each of the specialized Master's Degree Programmes in Entrepreneurship, Marketing and Leadership; and
- iii) One (1) student on each Bachelor's programme at MUBS Main Campus.
- iv) One (1) student on each Bachelor's and Master's Degree programmes at the MUBS Regional Campuses.

Procedure:

The Scholarship will be advertised once in an academic year (August - September) and applications shall be received within the specified period. The applications will be received and considered by the School Admissions Board.

Eligibility:

- i) One must posses an Admission Letter to one of the MUBS programmes for the current academic year.
- ii) One must be a First Class degree holder of a programme jointly offered by Makerere University and MUBS or a First Class Diploma holder of a programme offered and taught at MUBS Main Campus or its Regional Campuses in Mbale, Jinja, Arua and Mbarara.
- iii) One must be a citizen of Uganda, not more than twenty six (26) years of age (applicants for degree and masters programmes) or twenty (20) years of age (applicants for Diploma programmes) at the time of application.
- iv) The Candidate must provide their Uganda National Examinations Board (UNEB) UCE and UACE Results Slips and Certificates or their equivalent and Diploma/Degree transcripts/Certificates for verification.
